

Maximum tax benefits depend on timing. Here's how to complete your 2020 gift to YWCA Nashville & Middle Tennessee by year end.

Your gift by check

US Postal Service

- Date your check on or before Dec. 31, 2020, and
- Mail via U.S. Postal Service with postmark on or before Dec. 31, 2020.
- Gift checks mailed via U.S. Postal Service with postmark **and** check date on or before Dec. 31, 2020 will be counted for 2020 regardless of when they are received at YWCA Nashville & Middle Tennessee.

Other Delivery

- Date your check on or before Dec. 31, 2020, and
- Unfortunately, this year we can't accept hand-delivered checks at our office. Ship via FedEx, UPS, or other shipper so that it is received at YWCA Nashville & Middle Tennessee by 5 p.m., on Thursday, Dec. 31, 2020.

Your gift by credit card

Donations made by credit card are effective for tax purposes on the date the card is charged (processed by gift accounting).

Credit Card Gifts via U.S. Postal Service and FedEx/UPS Shipping

- Deadline is 5 p.m. (Central Standard Time) on Thursday, Dec. 31, 2020.
- Send to address above.
- **Important:** Your credit card gift must be received in Development's Office by 5 p.m., Dec. 31, 2020 deadline in order to be processed.

After Dec. 15, you may prefer to make your gift online or by telephone to avoid mailing or shipping delays and help assure your credit card gift is processed in time to count for 2020 tax purposes. See below for those deadlines:

Credit Card Gifts by Telephone

- Deadline is 5 p.m. (Central Standard Time) on Thursday, Dec. 31, 2020.

- Deadline is **11:59 p.m.** (Central Standard Time) on Thursday, Dec. 31, 2020

Your Gift of Securities (stocks, bonds, mutual funds)

- Gifts of securities (stocks, bonds, and mutual funds) require planning. The effective date of your gift for tax purposes depends upon how you deliver the gift. Use the deadlines below to ensure your gift counts for 2020.
- The amount of your charitable deduction depends on the value of the securities at the time the gift is complete.
- Start early to determine the fund's processing time, which varies from fund to fund. Some can complete your transfer within days of receiving your instructions; some take as long as six weeks.
- For all gifts of securities: Please notify the Development Department of your intention to make a gift of stock to the YWCA Nashville & Middle Tennessee. Phone 615-504-3799, or email cathy.kaiser@ywcanashville.com
